We accepted the younger kids, a while back, because the numbers were low and it stuck. We can't pick and choose who we except on the team [it all 5 or 6 year olds or none]. When we play teams with larger sized kids, we look at the smaller statured kids, and make a decision on play time and position based on size and knowledge of position being played. If we feel it isn't "safe" then we don't play them. With the 5/6 year olds there is a focus on learning to play; not the focus on competition and winning.

It is a group effort to coach and it's a group who decides who plays where.

It's important to state we are volunteers—some of us run our own businesses and need to be in contact with clients or customers to protect our livelihood.
